IN BRIEF

Listed firms garner ₹6.22 trn via pvt placement of bonds



Listed Indian companies raised a staggering ₹6.22 trillion through private placement of corporate bonds in 2017, an increase of nearly 5 per cent from the preceding year. The funds have been raised mainly for expansion of business plans, repayment of loans and to support working capital requirements.

According to the latest data with markets regulator Sebi, firms have collectively garnered ₹6.22 trillion through private placement of corporate bonds last year, higher than ₹5.95 trillion raised in 2016. Demonetisation led to a fall in interest rates (cost of borrowing) and ensured adequate liquidity in Indian capital markets, Bajaj Capital Senior VP and Head Investment Analytics Alok Agarwala said. The lower cost of borrowing and strong demand for corporate paper (from investors chasing yields) made it attractive for Indian companies to raise debt, he said.
