Sub: Increase in quantity of hazardous waste for FY 2022-23

Ref: Hazardous waste management authorization no. 328508 dt. 03.12.2021

With reference to the above referred Hazardous waste authorization no. 328508 dt. 03.12.2021, we are authorized to dispose 0.002MT of waste residues containing oil. We are burning the same in our incineration boiler at a high temperature of 900 degC, which is under operation for 11 months in a year.

Due to expansion activities, the quantity of waste residues containing oil increased from 0.002MT to 0.5MT. We have disposed the total quantity generated in our incineration boiler.

We request you to kindly consider the disposal process mentioned above being followed by us and also revise the authorization of waste residues containing oil from 0.002 MT to 0.5 MT.
