

Condition restricting export incentive under GST lifted

Delhi, 11 January

government has issued a notification withdrawing a condition that restricts availing of an export incentive under goods and services tax (GST), after various petitions were filed in courts against the scheme.

However, the petitioners say that they will not take back the petitions since the scheme had happened only prospectively.

Earlier, the Director General of Foreign Trade (DGFT) and the customs

department had imposed a condition that the advance authorisation scheme would be available to exporters only if imports have been undertaken by them.

This is termed pre-import condition, which was effective from October 13, 2017.

An advance authorisation licence is issued to allow duty-free import of inputs, which are used in exports. There was no such condition imposed on the scheme in the pre-GST period.

Change in the condition meant that imports done after exports cannot avail exemptions from IGST and compensa-

tion cess.

This led exporters and importers to move courts, including Delhi High Court, Gujarat High Court and Punjab and Haryana High Court as the directorate of revenue intelligence (DRI) started issuing notices to them.

Advance authorisation is generally used for importing goods after exports are undertaken, as against the pre-import condition imposed, said Abhishek Rastogi, counsel for the petitioners. As such, the condition defeats the purpose of the scheme, he added.
